If the clerk is not notified of a party's intention to appear, there will be no hearing and the tentative ruling will become the order of the court.**

### **Allison v. Salvo: 06CV4596**

This matter is continued to August 2, 2007 at 10:00 a.m. in Department 2. Plaintiffs are to provide notice of the continued hearing at the time of service.

New Case Management Conference Statements are required.

### **Citibank South Dakota v. Zegler: 06CV4600**

This matter is continued to August 2, 2007 at 10:00 a.m. in Department 2. Plaintiff is to provide notice of the continued hearing at the time of service.

New Case Management Conference Statements are required.

### **County of Amador v. Esposito: 06CV4593**

Defendants failed to comply with Local Rule 8.05. If there are any further violations of Rule 8.05, an Order to Show Cause will be issued and sanctions may be imposed.

This matter is continued to August 2, 2007 at 11:00 a.m. in Department 2. The parties should be prepared to discuss ADR options and set a trial date at that time.

### **Drummond v. Albertsons: 06CV4268**
