

DECEMBER 10, 2007 CASE MANAGEMENT CONFERENCE TENTATIVE RULINGS

To request a hearing on any matter on this calendar, you must call the Court at (209) 257-2692 by 4:00 p.m. today. Notice of the intention to appear must also be given to all other parties. If the clerk is not notified of a party's intention to appear, there will be no hearing and the tentative ruling will become the order of the court.

American Tile & Brick Veneer, Inc. v. County of Amador: 07CV4782

This matter is set for a 7-day jury trial commencing on May 27, 2008 at 9:00 a.m. in Department 2. This matter is set for a mandatory settlement conference on April 25, 2008 at 8:30 a.m. in Department 2.

The parties are encouraged to mediate this matter prior to trial.

California Casualty Indemnity v. Jones: 07CV4819

This matter is set for an order to show cause for failure to comply with CRC 3.740 on January 25, 2008 at 10:00 a.m. in Department 2. If proofs of service on all defendants are filed or an order for publication of the summons is filed at least 10 court days before the order to show cause hearing, the court shall continue the hearing to 360 days after the filing of the complaint.

The court will provide formal notice of the hearing.

Discovery Bank v. Emerson: 07CV4922
